Minutes from the December 14<sup>th</sup> meeting were reviewed. Lynn Rogers motioned to approve the minutes, seconded by Paul Wong. All were in favor, minutes approved.

### Old Business:

- Pennies: Discussion on how many new pennies to order, and how long they take to get. We budgeted \$10 per penny, but the estimate we received was for \$17. Natalie will check with last year's vendor and see if they will give us the \$10 price again.
  - Number of Players signed up to date: Lynn went over current registration. We have 19 paid registered players. Discussion on the boys who have said they are playing, but have not paid or registered. Laura will contact Gail and Cindy to see if they know the freshmen players who we have not heard from yet. Discussion on how to reach the other boys.
  - Discussion on getting players registered in order to make our budget numbers.

  - Lights will be needed for approximately 5 weeks. We budgeted for 4 lights, for 25 days. If more lights are needed, or for a longer period of time, we will have to see if we have enough in the budget to pay for it.

- Discussion on future meeting dates. Some dates were changed due to the game schedule and other conflicts. Paul will update the calendar.

- Paul is working with Lance, Trent, and Drew on making a Players Manual, Players Code of Conduct, and a Coaches Handbook.

Budget and Fees:

- Training fees to coaches: Paul met w/ Lance and the coaches. Drew will be getting the Head Varsity Coach stipend from the District and Trent will be getting the Assistant Varsity Coach stipend, although they will be Co-Head coaches on the field. The board will adjust our training fees to compensate for the discrepancy.
- Discussion JV Coaches Pay. Both the Head and Assistant JV Coaches training fees will be equal, with an additional training fee if they participate in the summer camp. Again, the Board will adjust our training fees so their total fees are equal.
